I'd like to know the following under the Freedom of Information Act over the last 12 months or financial year for North Tyneside Council:

1. What is the cost for the provision of Parking meters

The Council outsourced a number of its central "technical" services to Capita under a long term contract that commenced on 1st November 2012. The arrangement will last until 2022 but may be extended until 2027. As such the parking service is provided for the Council by Capita, which is a private company and as such is exempt from the provisions of the Freedom of Information Act.

2. What is the cost for the provision of Parking Permit spaces

3. What revenue is generated by parking meters

The Council offer the option of payment at its pay and display machines or payment by mobile phone.

In the financial Year April 2018 to March 2019, North Tyneside Council generated £723,120 from charges in off-street (car park) facilities and £1,155,530 from charges in on-street facilities.

4. What revenue is generated by the provision of Parking /Permits

The income received for parking permits cannot be separated within the Council's finance system

5. What revenue is generated by penalties for non payment/incorrect use of parking meter spaces

This parking offence is not a specific contravention code established by the Department for Transport so cannot be obtained through any report available within the Notice Processing System.
