For questions 3a to 3c please see the <u>Adult Social Care Activity and Finance Report</u>. NB: Data for 2015/16 is not held.

In addition to the information contained in the Short and Long Term (SALT) returns above; North Tyneside Council commissions North Tyneside Carers Centre (NTCC) to deliver a range of support services; this support includes information, advice and guidance and 1-1 support; and carers surgeries.

The number of carers registered with NTCC are as follows:

- 2015 2016: 35202016 2017: 3823
- 2017 2018: 3817
- 2018 2019: 2366 (NB: Numbers decreased following the introduction of GDPR and a data clean up)

NB: There may be duplication in the numbers recorded by NTCC and the data provided in the SALT returns.

4. How many carers are currently supported by the council?

219 carers are currently being supported by NTC. In addition, the carers registered and noted above are being supported by North Tyneside Carers Centre in a range of ways. NB: There may be duplication in the numbers recorded by NTCC and the data currently held by NTC.

Carers can also access a range of support and activities provided by the carers centre (although all are not directly commissioned) which includes training, social activities, peer support, one to one support and counselling.

5. How many respite care beds are commissioned by the council for use by council-supported carers (whether currently occupied or not)?

The Authority commissions six dedicated respite beds for adults with a learning disability. All other respite is spot purchased from a range of providers and subject to choice and availability.

6. Please provide any data the council holds on the occupancy rate of respite care beds - this may be restricted to council-commissioned beds, or include beds that may be purchased with direct payments/personal budgets.

The occupancy rate of the commissioned respite beds between 19th Aug 2019 and 15th Sep 2019 was 76.8%.
