There is no eligibility for "chaperone support". The Local Authority request information on whether a passenger assistant would be required. If the Local Authority is advised that a passenger assistant is required then this is always provided. The % is therefore 100% for each of the years from 2015. Data prior to 2015 is not held..

5. What quality assurance processes do you have in place to ensure that home to school transport provision, including but not limited to training of the chaperone and driver, type of vehicle, length of journey and needs of other children on board, for children aged 5-16 on the basis of SEND is appropriate to meet each individual child's needs?

Any special requirements for transport are made from the school/social worker/parents, risk assessments are carried out as appropriate. The size of the vehicle depends on the nature of the school and maximum journey time is 45 minutes. Awareness sessions and parent introductions take place if necessary.

6. What is your planning process, including timescales, for ensuring the provision of home to school transport for children aged 5-16 eligible on the basis of SEND, and what data sources do you use to support this process?

Planning starts at the end of February, in order to have the transport in place for September, planning includes liaison with our Special Educational Need & Disability (SEND) Support Service and Schools regarding pupils leaving/joining. Also, once any new routes are established these need to be tendered in accordance with legislation and liaison with contractors regarding schedules and times confirmed.

Data Sources used are Access Database and QRoutes.
