What estimate do you have of persons leaving maintained secondary school in your authority who have a literacy level of entry level three, as defined by the 2011 Skills for Life Survey. Or, if not possible, what other estimates you use for measuring levels of literacy?

We do not have an estimate of the numbers of school leavers at entry level three. Although Entry Level 3 qualifications remain important as a gateway to Level 1 and Level 2 qualifications we expect all pupils, except those with the more severe learning difficulties, to be able access the GCSE or equivalent Level 1 or Level 2 qualifications. Accessing any such qualification requires literacy at level 1. Rates by school can be found in the DfE compare schools website: https://www.compare-school-performance.service.gov.uk/ and search for schools in North Tyneside. The best indicator for this level of functional literacy would be pupils achieving "at least 1 qualification". Those pupils unable to access these qualifications will be receiving individual support post 16, many could have been assessed to have entry level 1 to 3 literacy skills but many will not have been formally assessed under that scale.
