NB. Contacts to Referrals are recorded as Education and School sources, rather than separated into Primary or Secondary schools (we also have a three tier system in some parts of the borough). For this reason I have grouped the totals for 1&2; 3&4; 5&6; 7&8.

Answer: The Council received 65 referrals to children's services from School or Education sources in 2019 between and including 23rd March and 1st September

- 3. In 2020 between and including 23rd March and 1st September how many referrals did the Council receive to children's services from primary schools?
- 4. In 2020 between and including 23rd March and 1st September how many referrals did the Council receive to children's services from secondary schools?

Answer: The Council received 33 referrals to children's services from School or Education sources in 2020 between and including 23rd March and 1st September

- 5. In 2019 between and including 2nd September and 3rd December how many referrals did the Council receive to children's services from primary schools?
- 6. In 2019 between and including 2nd September and 3rd December how many referrals did the Council receive to children's services from secondary schools?

Answer: The Council received 54 referrals to children's services from School or Education sources in 2019 between and including 2nd September and 3rd December

- 7. In 2020 between and including 2nd September and 3rd December how many referrals did the Council receive to children's services from primary schools?
- 8. In 2020 between and including 2nd September and 3rd December how many referrals did the Council receive to children's services from secondary schools?

Answer: The Council received 101 referrals to children's services from School or Education sources in 2020 between and including 2nd September and 3rd December
