a. According to the DWP, you were allocated £644,9881 + £224,228. How much of this allocation did you spend in 2020/21?

£844,904.61 was spent of the grant - the period of the grant was extended to 16.04.21 so the spend is up to this date.

- b. Approximately what % (if any) of this fund was used to provide direct local welfare assistance grants to individuals/households in 2020/21? Answer: approximately 33% was spent by the LA on direct support to individuals by the LA, through welfare assistance and other teams in the LA.
- c. if this fund was used to provide direct grants to individuals or households, how many were awarded in 2020/21?

Approximately 5,011 households benefitted from payments/support by the LA. (9,464 benefitted through Third Party Organisation support)

d. If the answer to B is less than 100%, please provide approximate percentages indicating what the remainder was spent on (e.g. xx% of the fund was allocated to local food banks, xx% was allocated to schools for food vouchers, etc.).

£562,032.30 (approximately 67%) of spend was provided through Third Party Organisations (TPO's) which include schools and the community and voluntary sector organisations.

£423,690 (approximately 75% of TPO spend was through schools for food vouchers) the remainder of TPO spend was provided to organisations to provide food, utility and voucher support)
