- 8. Name of the party/parties that paid the contribution
- 9. Name of the party/parties that have been repaid and when
- 10. All council spreadsheets that contain the requested information
- 11. Please include either copies of the s.106 agreements or live links to where the agreements can be found.

- 4. Please see attached FOI Oct 2022 Planning Records spreadsheet for information as to the purpose of the obligations set out in each legal agreement. Planning department did not hold information on spending nor dates of expenditure. The Authority's finance department migrated to a new ledger system in 2014. Information prior to this period is not readily available in line with the Authority's data retention policy.
- 5. To provide this information would require a search of each individual planning application records. Therefore, this part of the request is refused under s12 (1) Freedom of Information Act 2000, since the cost of complying would exceed the appropriate limit set out in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004.

In assessing the cost of complying, the costs attributable to officer time involved in complying have been considered. Such costs are limited to £450.00 under the Regulations, which equates to eighteen hours of officer time.

You may wish to refine your request by narrowing its scope by being more specific about what information you particularly wish to obtain, including any dates or period relevant to the information required.
