Request:

In July 2013 the Department of Health announced a series of reforms to the system of providing adult social care in England. This was backed by a commitment by the Department of Health, Local Government Association and ADASS to work in partnership to ensure smooth delivery of these reforms. (Under the Conservative/Liberal Democrat coalition government.)

Specifically, the new system would include a new cap of £72,000 on eligible care costs for people at state pension age and over, and additional financial help for people with less than £118,000 in assets including their home. There would be annual 'care account' statements to project when someone will reach the cap or qualify for additional financial support.

The Department said this would come into effect in 2016. (However the policy was postponed until 2020 in 2015.)
