- 1. Yes
- 2. Guidance is included on the label of the product, this is followed by the operator. Integrated weed control is practiced by the grounds maintenance team. Standards are set for our weed control contractor and all our in house operators are appropriately trained. The most effective and efficient approach to weed control is taken not just financially but in other ways such as carbon use. Integrated management does not mean chemicals are not used, often are the correct choice, but we do ensure alternatives are considered.

The weed control contractor is to use spot treatment and target weeds only. Infra red technology is being pursued to improve on this further.
