Request:

1.The number of potholes reported to the council

All reported enquiries regarding defects within the carriageway are recorded on our electronic Symology data capture system, however, the system does not split which ones relate solely to potholes and which are for other issues such as requests for major surfacing works, therefore, we are unable to provide the figures for how many individual potholes were reported.

We can, however, identify how many reports we received for all defects in the carriageway which resulted in an inspection.

1st April 2019 to 10th March 2020 = 606 reports (unable to state how many were specifically about potholes)

1st April 2018 to 31st March 2019 = 1120 reports (unable to state how many were specifically about potholes)

1st April 2017 to 31st March 2018 = 1107 reports (unable to state how many were specifically about potholes)

1st April 2016 to 31st March 2017 = 831 reports (unable to state how many were specifically about potholes)

1st April 2015 to 31st March 2016 = 814 reports (unable to state how many were specifically about potholes)

2.The number of potholes repaired

1st April 2019 to 10th March 2020 = 8471 potholes repaired

1st April 2018 to 31st March 2019 = 7852 potholes repaired

1st April 2017 to 31st March 2018 = 6322 potholes repaired

1st April 2016 to 31st March 2017 = 8213 potholes repaired

1st April 2015 to 31st March 2016 = 7175 potholes repaired
