Between the 1 April 2016 and 1 February 2021 the following domestic properties were registered for Council Tax in North Tyneside. The movement between years represents the net growth in additional housing. It is impossible to state how much Council Tax has been raised from these additional properties without interrogating each individual Council Tax account. This is because some of these households would be in receipt of Council Tax support, or other discounts and exemptions and this information is not easily accessible without considerable work.
