Yes all methods of contraception including long-acting contraceptive methods (intra-uterine systems, intra-uterine devices and implants) are offered to all women regardless of age and place of residence. The only exception is Emergency Hormonal Contraception offered through Community Pharmacies - this is only offered to women under the age of 25 years.
