As this information contains confidential information and is commercially sensitive, disclosure would prejudice NEPO and the suppliers commercial interests as knowledge of termination clauses may allow competitors to focus their efforts around certain sites providing them with commercial advantage. Furthermore the termination requirements specifically designed by NEPO and then used in legal agreements have commercial value to NEPO in their own right. As a consequence, I have determined that the information requested is exempt from disclosure by virtue of Section 43(2) of the 2000 Act.
