These matches were identified from eleven different report types and to include a total aggregated value could be misleading due to different methods in calculating values in each report. For example, one value may relate to a specific individual payment, another value in a different report may be the total amount paid to a supplier in a specific time period, and to aggregate these values would be misleading. NB not all matches are errors.
Errors followed-up (£)	Using a risk assessed process a number of the 1591 matches in the 2016/17 exercise were subject to review, however specific records of each match reviewed were not maintained and the exact number is not held. A number of the matches reviewed identified errors, however as the NFI exercise is based upon historical data, the majority of these had already been identified and resolved through the Authority's internal procedures independent of the NFI exercise. Errors that had not already been identified, and were therefore subject to 'follow-up' totalled £37,025.11.
