For each of these time periods, could you provide the following information?

- 1) Please could you provide a list of the local authority areas (including your own) where you offered temporary accommodation to homeless households, and **for each local authority state how many households were located in each authority?** (eg London Borough of Barking and Dagenham 4)
  - a) May 1, 2008 April 30, 2009

We do not have the information requested for this period

b) May 1, 2015 to April 30, 2016

During this period we did not provide temporary accommodation out of the area to any household during this period

We accommodated 112 single applicants and 73 families within the Local Authority area
