**increases as the penalty charge progresses through the statutory process. It may also include County Court costs if the penalty charge is unpaid and the debt registered. If a Warrant of Execution is subsequently obtained and passed to an Enforcement Agent, then they can add additional costs to the debt to cover their costs.**

**The Authority cannot break down the income received from parking fines issued in a financial year from the income received from bus lane fines issued in the same year. All the income is received in the same fund stream and includes payments made in this year for penalty charge notices that may have been issued for parking and bus lane contraventions in previous years.**
