In this FOIA Request:

When we refer to "residential care home providers" this includes where the council itself operates the care home and where any company in which the council has an interest (either directly or indirectly) operates the care home;

We only request information as it relates to beds funded 100% by the council and not where the cost of such a bed is funded wholly or partly by any NHS body; We request information related to all adult social care funded 100% by the council; and When we refer to "Yr1, Yr2 and Yr3" we are referring to the council's financial years (1) 2016/17, (2) 2017/18, and (3) 2018/19.

What is the standard rate per bed payable to residential care home providers that the council set in each of Yr1, Yr2, Yr3? Please provide the standard rates for all different bands/categories of services that the council set including a description of the band/category of service e.g. standard residential, residential special needs etc.

See attached documents titled "Schedule of Residents Fees 16-17", "Schedule of Residents Fees 17-18" & "Schedule of Residents Fees 18-19"

For each of Yr1, Yr2 and Yr3, please provide the average price per bed that the council paid to residential care home providers in each of the bands/categories of services that the council has included in its response to Question 1.

The average can be calculated using the data provided in response to questions 1 and 3.

For each of Yr1, Yr2 and Yr3, please provide the total number of beds purchased by the council from residential care home providers split into the bands/ categories of services that the council has specified in its answer to Question 1.

This data is based on a snapshot on 31st March of each year. It includes both Long and Short term clients. It does not include out of borough placements, self funded clients, shared care clients, chc clients or S117 clients. It only includes clients under the older peoples expenditure code and therefore does not include clients with more specialist needs (MH, LD or PD).
