Questions 2 and 3 are refused under s12 (1) Freedom of Information Act 2000, since the cost of complying would exceed the appropriate limit set out in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004.

The reason for this is that there is no report that can be produced or created to identify the information. The only way it could be gathered would be to manually examine each of the 68,183 accounts listed on the summons reports. Based on 30 seconds for each account that would amount to over 568 hours.

In assessing the cost of complying, the costs attributable to officer time involved in complying have been considered. Such costs are limited to £450.00 under the Regulations, which equates to eighteen hours of officer time.
