**Request:**

Under the terms of the Freedom of Information Act I would like to request details relating to total spend on textbooks in your Local Education Authority.

In particular, I would like to request the following information:

1. How much was spent on textbooks in total by a) primary schools and b) secondary schools in each of the last five financial years?

We do not hold individual school spend down to a specific level of expenditure. The information we hold is taken from the schools Consistent Financial Reporting (CFR) submission which is reported to the DfE annually in July. This is based on the DfE expenditure and income coding structure and does not give detail down to the specific level of textbooks. The costs of the textbooks will be included in learning resources CFR code E19 - see Q 2.

2. How much was spent in total on all classroom learning resources by a) primary schools and b) secondary schools, with an indication of what resources this would cover, in each of the last five financial years.

Table below shows the spend in the CFR category E19 Learning resources

- furniture used for teaching purposes
- pupil travel for work experience placements
- purchase, lease, hire or maintenance contracts of audio-visual or other equipment used for teaching
- reprographic resources and equipment used specifically for teaching purposes
- school trips and educational visits
- servicing and repairs to musical instruments and PE equipment used as part of the curriculum
- subscriptions, publications, periodicals and copyright fees associated with the curriculum, including sums delegated by the LA (not nationally administered licences purchased by the Secretary of State)
- teaching materials
- television licence fees used for teaching purposes 23
- payments to alternative provision services including pupil referral units (PRU), non-maintained special schools (NMSS), and independent schools
- primary school PIP examination costs
- payments made to students in receipt of the 16-19 Bursary Fund
