In the new unit the bar area will be in a designated part of the warehouse. The other part being the beer distribution business. This is sealed off from the bar area and any beer distribution activity will be carried out behind closed doors and outside of the bar hours.

At 6 Barrels we aim to extend the Fish Quay's hospitality hub on Northumberland Street, establishing a destination venue linking with other local breweries and pubs in North Shields. We aim to work with the local businesses on Northumberland Street in providing a safe, fully DDA accessible venue.

The location is perfect, set on a commercial street scene with established breweries and commercial properties. These being:

- Flash House Brew Co
- The Kiln Studios
- BDS Motorcycles
- Low Quay Brewery
- Custodian Total Security Services
- Percy Hudson
- The Yard

We will offer an extensive range of beers and a limited selection of spirits and wine. Light snacks such as crisps will also be available.

Unopened cans of beer will be available to purchase to take home/away from the premises.

The bar area will have fixed seating, loose seating for 28 covers, servery, x1 male toilet and x1 unisex standard accessible toilet (standard 1.7mx2.2m). It will be utilising an existing off-street entrance with x2 steps (internal, as existing) and a shutter entrance for accessible entrance at ground level. This will give full access for DDA requirements. We aim to allow full DDA access in a community driven location adding vitality and access for everyone. There will be additional loose seating for 24 covers in the warehouse area.

LICENSING OBJECTIVES

a) General – all four licensing objectives (b,c,d,e)

Responsible trading will be a core value of the business, we will work with all relevant authorities to ensure that the premises only has a positive impact on the street and town centre. Our high quality and unique offer will create an environment that minimises any negative aspects of premises licenced to sell alcohol.
We will pay particular attention to ensuring alcohol is only served to persons over 18, and the zero tolerance of irresponsible consumption and anti-social behaviour.
All staff will be trained in all aspects of the operational procedures of the business which will promote the licensing objectives. Procedures will be reviewed, and training records maintained. Staff will fill out all relevant documents in relation to the licencing objectives e.g. refusals register.
Only responsible consumption of alcohol will be promoted, there will be no cheap drinks promotions or alcopops. Various small measures will be available across all alcoholic beverages and a range of low/no alcohol drinks will be promoted within the offer.

b) The prevention of crime and disorder

A CCTV system shall be designed, installed and maintained in proper working order, to the satisfaction of the Licensing Authority and in consultation with the Police. It will cover the entrance and front of the premises, the main seating area, behind the bar and the side exit/seating area. The system will have capacity to store footage from the previous 28 days and the hard drive will be stored in a secure location. The footage will be available upon request to all relevant authorities and a sign informing the members of the public CCTV is in operation on the premises, will be displayed in the window.
There is a roller shutter on the door and the side warehouse entrance.
Any customers who appear to be intoxicated will not be served, and recorded in the refusals register, which will be kept behind the bar.

c) Public safety

Risk assessments of all activities within the premises will be carried out and used to create the operational procedures of the business to ensure a safe environment for staff and customers.
Staff will be trained in all aspects of health and safety and environmental health requirements.
The maximum capacity of the premises will be adhered to at all times.
Staff will ensure walk ways and escape routes are kept clear at all times.
An incident report book will be kept behind the bar and filled in by staff. This will be reviewed regularly to ensure operational procedures are safe.
All equipment in the premises will be regularly inspected and maintained. Records of these checks and actions will be kept.
Four smoke alarms, one in the front entrance, one in the toilet and two in the bar area.
All aspects of the premises will be kept in a good safe condition.

d) The prevention of public nuisance

The proposed type of establishment and its clientele will contribute to the prevention of the public nuisance objective. Any deliveries to the premises will be carried during the day, in a manner that will not cause noise pollution to the surrounding area.

Glass waste will not be removed from the premises and placed into the outside bins on an evening. Instead this will be carried out the following day.

All waste will be secured in bins within the premises.

Staff arriving early and leaving late will be trained to carry out their duties without causing any significant noise levels.

Customers will not be permitted on the premises outside of the designated opening hours.

All customers will leave the premises within 30 mins of time being called at the bar.

Staff will remind customers to leave the premises in a quiet and respectful manner.

Signs will be placed at the main entrance and exit for the premises asking people who are leaving to be considerate of neighbours and refrain from shouting and creating an unreasonable disturbance when leaving.

Noise from the licensed premises shall not be audible beyond the boundary of the premises so as to cause nuisance to nearby residents or other business users.

Sufficient bins will be provided to prevent any litter.

Staff will ensure the street outside the premises is maintained and tidy as part of opening procedure.

e) The protection of children from harm

Supervised children will be allowed on the premises given the proposed type of establishment and clientele. Staff will ensure that unsupervised children are not permitted on the premises.

A challenge 25 policy will be in place, a sign advertising this will be displayed behind the bar. Staff will request valid photo ID from any customer believed to look under 25. All sales of alcohol will be refused unless valid photo ID is produced. A refusals register will be kept behind the bar.

Staff will be trained in valid forms of photo ID in order to only authorise the sale of alcohol to those persons who are over 18.

A strict no ID, no sale policy will be in operation at all times.

NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is a British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A **current** Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
 - evidence of the applicant's own identity – such as a passport,
 - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
