a) General – all four licensing objectives (b,c,d,e)

The premises will be operated in a responsible manner and with due regard to the promotion of the licensing objectives at all times. Comprehensive procedures will be implemented covering crime prevention, public safety, public nuisance and the protection of children from harm. All staff engaged in the sale of alcohol shall receive training in the Licensing Act 2003, responsible alcohol retailing and the safeguarding of customers. There will only be low level background music played in the premises and the offering will be predominantly real ales, wines and premium spirits, and no televisions or karaokes will be played. Prominent signage will be displayed at exit doors requesting that customers respect staff, neighbors and the local community when leaving

b) The prevention of crime and disorder

The premises will operate a strict Challenge 25 policy, requiring all customers who appear under 25 years of age to produce acceptable photographic identification prior to the sale of alcohol. A refusals register shall be maintained and made available for inspection upon request. No alcohol shall be sold to any person who appears to be intoxicated or behaving in a disorderly manner. A cctv system is installed covering entry/exit and internal customer areas, with recordings retained for 28 days and made available to responsible authorities upon request. Due to the small capacity, staff will be able to maintain effective supervision of all patrons at all times. Any incidents of crime and disorder will be logged, and the premises licence holder will cooperate fully with the police and relevant authorities.

c) Public safety

The premises shall at all times comply with fire safety and health and safety legislation. All fire exits shall be kept clear, unobstructed and clearly signed. A first aid kit shall be available on the premises at all times and staff will be trained in its use. Firefighting equipment will be maintained and regularly checked and emergency evacuation procedures shall be in place and practiced regularly.

d) The prevention of public nuisance

The premises shall be operated so as to ensure that no nuisance is caused to local residents or businesses. Doors shall be kept closed, save for access and egress, in order to minimise noise escape. Only background recorded music shall be played at a low volume, there will be no provision of live or amplified entertainment. Prominent notices shall be displayed requesting that patrons depart the premises quietly and with respect for neighbours. All waste shall be stored securely and disposed of in a responsible and timely manner. Deliveries and collections shall be managed to minimise disturbance. Staff will monitor the immediate vicinity to prevent patrons from consuming alcohol outside.

e) The protection of children from harm

The premises operates a strict Challenge 25 policy and maintain a refusals register. No unaccompanied children shall be permitted on the premises and the premises is not intended to provide activities or entertainment suitable for children. All alcohol will be stored securely behind the counter to prevent unauthorised access. Staff are trained in their responsibilities under the Licensing Act 2003 in relation to the protection of children, including recognising and responding appropriately to safeguarding concerns.

NOTES ON REGULATED ENTERTAINMENT

In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
