Early Years Funding

The majority of the respondents to the consultation agreed that North Tyneside's Funding Formula for 2019.20 should be maintained at the current level.

Central Block Funding

Centrally Retained Items (appendix A)

This remains unchanged from 2018/19.

Discussion followed around:

- Primary and Secondary schools buy into SLAs however there are different levels of support to choose from
- This funding is always used and is often topped up by the LA
- Colleagues were reminded that officers from the relevant services attended previous Forums to describe how the funds are used
