Title of Briefing: Education Capital Investment - Update

1.0 Purpose / Issue

This Briefing Note provides Schools Forum with the most up to date information associated with the Education Capital Investment across the school estate.

2.0 Priority Schools Building Programme (PSBP)

The Priority Schools Building Programme is the Government's national investment programme aimed at addressing the needs of some of the worst condition schools in the country.

The investment strategy targets individual school buildings, as well as whole school rebuilds where this is appropriate

2.1 - Priority Schools Building Programme 1 (PSBP 1)

- The project at Whitehouse Primary School is fully completed
- Longbenton High School and Marden High School are fully completed with the contract now within the external defects liability period.
- The external works for John Spence High School were completed at the end of December 2017 and the contract has now moved to the external defects liability period.

2.2 - Priority Schools Building Programme 2 (PSBP 2)

Cullercoats Primary School was identified as a successful bid under PSBP 2 in February 2015.

Following the Client Engagement meeting held on 30 January 2018 with Officers and representatives from the School, the Education Skills and Funding Agency (ESFA) have now confirmed the proposal for the refurbishment project at the school which will include replacement windows, roof, mechanical and electrical services and internal alterations and improvements.

The ESFA confirmed the following works programme on 6 March 2018:

- 21 May 2018 modular accommodation arrives
- 18 June 2018 main works commence
- 18 June 2018 Phase 1 Nursery KS1, south hall
- 23 July 2018 Phase 2 Main spine corridor (heating and electrics)
- 7 January 2019 Phase 3 Lower KS2
- 22 July 2019 Phase 4 Upper KS2
- 22 July 2019 Phases 5 Admin areas
- 10 February 2020 Phase 6 external works
- End of February 2020 Completion and handover

3.0 Backworth Park Primary School

A new build solution funded via Section 106 contributions in relation to local housing developments. The project involves relocating Backworth Park Primary School to a new site to accommodate local increase in pupil population as a consequence of existing and newly approved residential developments. As part of the development proposals the school will also expand from a 1 form entry to a 1.5 form entry.

The works commenced on site in August 2017 and the project is progressing well with an anticipated completion date of July 2018. The transfer of resources etc will be undertaken during the summer holiday period to allow the new school to open to staff and pupils in September 2018.

4.0 School Condition Investment Programme

- **2017/2018** The approved Capital Maintenance Programme was fully delivered with 20 schools benefitting from the investment.
- 2018/2019 The Strategic Investment and Property Team carried out the formal consultation with all schools in November 2017 on the draft 2018/19 programme. The final investment programme was published in December 2017 detailing those priority projects to be delivered during the new financial year (Appendix 1). Individual meetings have now commenced with those schools included within the programme to agree the project detail and delivery arrangements.
- 2019/2020 Future years School Condition Investment priorities will be identified once the ESFA announce the capital allocations for 2019/20 and beyond. This will allow the team to capture any new or emerging priorities across the school estate.

5.0 Special Provision Capital Fund

The purpose of the special provision capital fund is to support local authorities to make capital investments in provision for pupils with special educational needs and disabilities.

The funding is primarily intended to develop provision for pupils with more complex special educational needs (i.e. an EHC plan aged between 0 and 25) in mainstream and/or special schools.

The funding has been allocated based on a formula allocation and is based principally on projected population growth for children and young people aged 2-18 between the years 2018/19 and 2020/21. The allocation for North Tyneside is £500k and covers a three year period 2018/19 to 2020/21 as shown below:

By Summer 2018 Local Authorities are required to publish their plan and have consulted with parents, carers and young people.

Colleagues from the School Improvement Service are currently working with Headteacher colleagues and the High Needs Commissioning Group to identify the initial priorities.

6. Healthy Pupils Capital Fund (HPCF)

As part of the Capital allocations announced in March 2018, North Tyneside Council were awarded £254k for 2018/19 as part of the Healthy Pupils Capital Fund. The funding is provided from the Soft Drinks Industry Levy for 2018/19 only. The one off capital allocation is to help local authorities to improve the physical and mental health of children and young people by improving and increasing availability to facilities for physical activity, healthy eating, mental health and wellbeing and medical conditions.

The capital allocation awarded to North Tyneside does not include Academies or voluntary aided schools as funding for these sectors has been provided direct to Diocesan Authorities and Academies.

An initial meeting has been held with the Director of Public Health and colleagues from the School Improvement Service to consider the options on how best to deliver investment across North Tyneside. It is proposed that a mini health profile is drafted of our young people and to link this to the recent Healthy Schools Audit.

Upon completion of this exercise, Headteacher representatives will be asked to work with colleagues to help agree a final investment strategy for delivery by 31 March 2019

7.0 Recommendation

Schools Forum is asked to note the contents of this Briefing Note and the progress made.
