7. Have you carried out any engagement in relation to this proposal? If so, what?

Cabinet on 11 December 2017 is to be asked to approve a process of engagement on the draft North Tyneside Cycling Strategy. As part of the development of the draft strategy we have considered the priorities set out in the Our North Tyneside council plan developed following extensive public consultation including the Big Community Conversations; data on usage of cycle routes, measured by electronic counters; technical data relating to our transport networks; Census data from the Office of National Statistics, including travel to work data; specific feedback received from the community through enquiries from Ward Members and the public; and specific consultation undertaken by the Cycling Strategy Study Group of Overview, Scrutiny and Policy Development Committee.

In accordance with the decision of Cabinet on 15 January 2018, a process of public engagement was carried out on the draft North Tyneside Cycling Strategy over a four-week period up to 21 February 2018. The draft strategy and a questionnaire were made available on the Authority's website, and in hard copy at libraries and Customer First Centres, for people to read and give feedback: people were able to submit their views by email or letter. Copies of the draft strategy were sent to all Members, to officers of neighbouring authorities, and to user groups: a workshop with user groups also took place.
