Ambition for North Shields and the Fish Quay

North Shields Embankment Walkway – 3 March 2022

Dear Sir/Madam,

As part of North Tyneside Council's ambitious plans to improve North Shields and transform the town into a residential location of choice and an attractive, family-friendly destination we are developing a new embankment walkway linking the town centre to the Fish Quay.

It forms part of our aims to create a smaller but more vibrant, high-quality town centre; to create more flexible retail opportunities and expand the evening and weekend economy; to improve public transport and the quality of walking and cycling connections across the town (including better links to the Fish Quay); and to raise and improve the quality of the built environment and the quality of public space in North Shields with more of it suitable for hosting events and festivals.

The scheme is being delivered by our appointed construction partner Wilmott Dixon.

We'd like to thank everyone who has provided their views on the walkway so far – these are being considered closely and the designs are being adapted to reflect a number of comments. The public will be consulted again on the updated plans in due course as part of the planning process.

In the meantime, initial pruning of dense vegetation on the embankment will commence very shortly ahead of bird nesting season. We are working closely with ecologists during the works to identify any wildlife in the area and avoid any negative impact.

The full clearance of the vegetation in the area will follow at a later date to accommodate the new pathways. The new scheme will involve extensive planting, resulting in greater biodiversity than there currently is in the area.





During the initial pruning work, there will be no traffic restrictions although the stairs near the Stag Line Building will be closed. Ropery Stairs will remain open.

Works are expected to start week commencing March 7 and will be undertaken from 8.00am to 4.30pm. There will be information shared on the Council's social media channels and website as work begins.

We are working hard to minimise disruption and we would like to thank you for your patience. We will continue to keep you updated throughout the duration of the project.

The new high-quality walkway is aimed at improving access where accessibility can be difficult between the improved town centre and vibrant Fish Quay, making it easier for people to travel between the two parts of town.

The walkway will feature green open spaces and there will be route options to suit different needs, including step-free routes and steps with handrails, as well as a direct route from top to bottom via steps.

The scheme is being designed with environmental sustainability and safety at its heart and it will become an attraction in its own right and provide benefits for health and





wellbeing. It also features provision for artwork to be displayed and potential commercial opportunities.

The aim is to attract more people to the area and vastly improve the appearance of the local landscape.
