4. Executive summary

The purpose of this report is to seek approval from the Director of Children's Services to the proposed increase to the current Accredited Foster Carers' fee from £110 to £220. This is the lowest paid fee to our foster carers.

The Authority has faced significant challenge in recruiting sufficient numbers of Foster Carers to meet the needs of the Borough, in particular Foster Carers skilled at caring for teenagers, and Foster Carers who are skilled at caring for sibling groups. Set against this challenging need, the Authority is recruiting in a competitive marketplace where other Local Authorities and Independent Fostering Agencies (IFA'S) are also actively recruiting residents within the Borough.

A refresh of the Fostering Strategy was completed in 2022 to ensure we were offering a competitive financial package of support by aligning the Authority's fostering allowances to the Government's recommended levels. This refresh also introduced a second child fee of \pounds 75 for carers to support them to care for more than one child and for each child thereafter. However the strategy did not alter the main 3 fee bands paid to each fostering household.

This proposal is to align the level 2 fee from £110 to £220 per week. This would bridge the gap between the Pre accredited zero payment and the Advanced banding of £380 and be more attractive when recruiting new carers to the Authority enabling the Authority to remain competitive in recruitment and retention of existing foster carers.

5. Alternative Options Considered

Do not increase the accredited foster carer's fee of ± 110 to ± 220 .
