4. Executive summary (To be taken from written report)

On 6 June 2023 the Director of Regeneration and Economic Development authorised

- (1) that notices for the proposal should be prepared and advertised in line with relevant statutory requirements;
- (2) that, in the event that no objections are received following the period of consultation, that the circumstances do not warrant the holding of a Public Inquiry; and
- (3) that if no objections are received following the period of consultation required by statute, the Traffic Regulation Order shall be made.

The notices were prepared and advertised in accordance with the statutory requirements and no objections were received during the statutory advertising period.

Therefore, the circumstance does not warrant the holding of a Public Inquiry and the Traffic Regulation Order (TRO) should be made for the introduction of variations to restrictions on waiting and loading which involve the introduction of 'no waiting at any time' restrictions (double yellow lines) on Stephenson Street, Suez Street and Upper Norfolk Street, North Shields, in accordance with section 1.5.2 of the Delegated Decision Report of 6 June 2023.
