Therefore, the circumstances do not warrant the holding of a Public Inquiry and the Traffic Regulation Order (TRO) should be made for the introduction of an HGV (7.5 tonne) restriction in accordance with section 1.5.1 and Appendix 1 of the Delegated Decision Report of the 5th March 2025.
